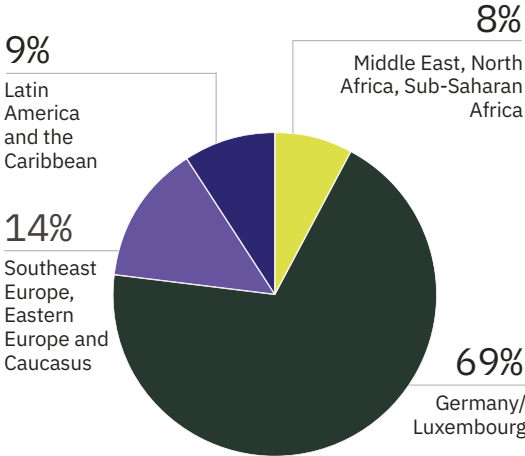

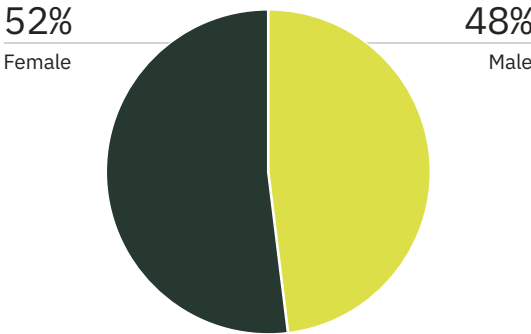
Staff by location

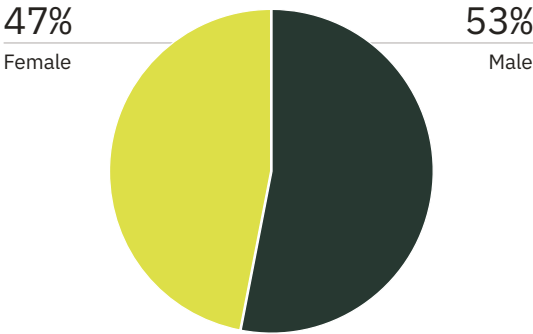
Staff by gender

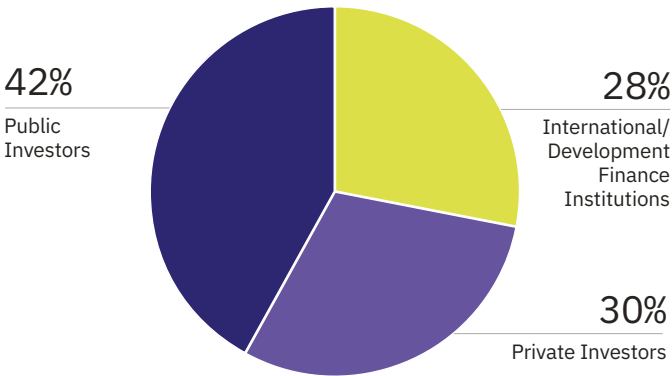

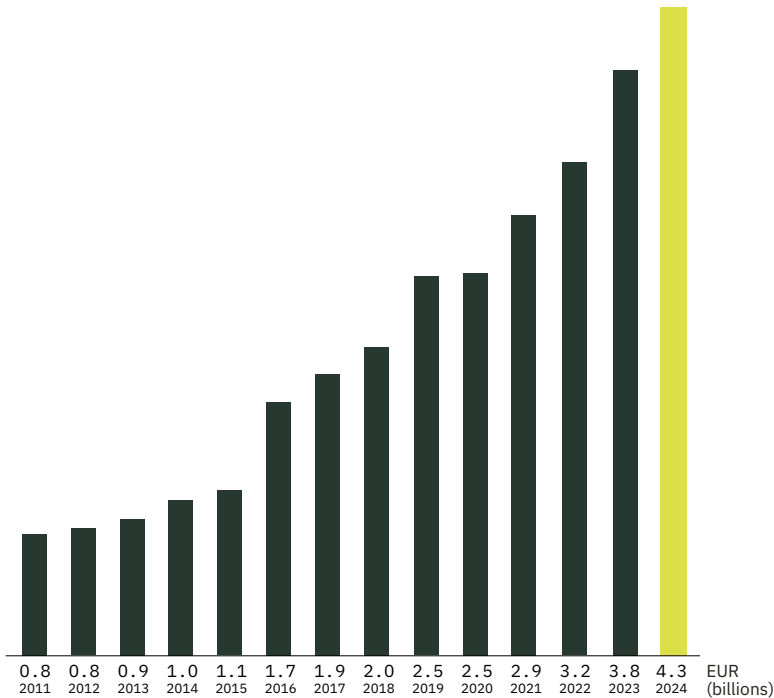

by type

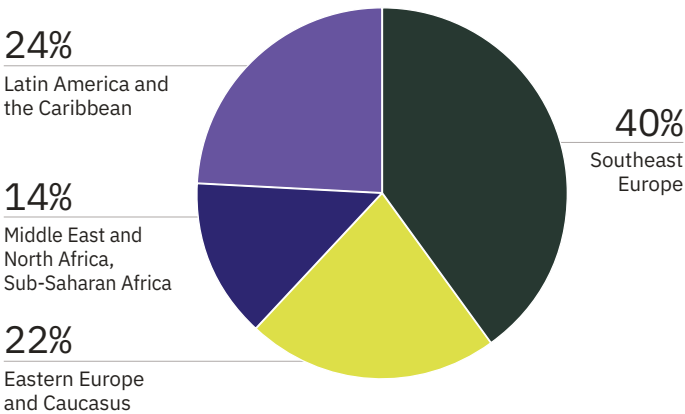


Growth in assets under advisory/
management in EUR (billions)



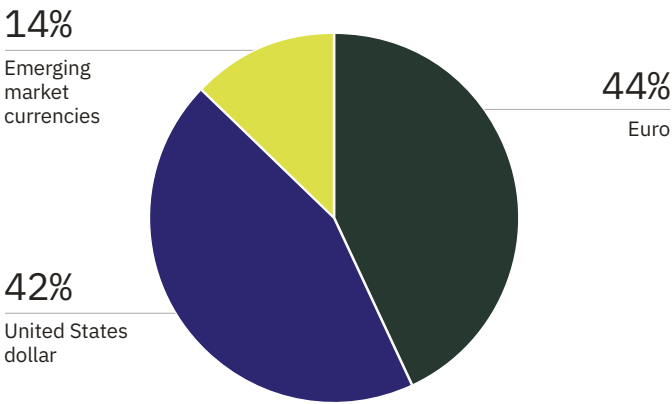
Outstanding investment portfolio

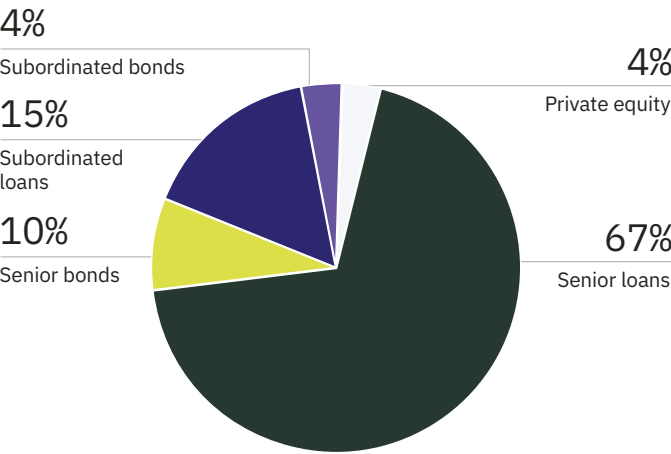
Outstanding investment portfolio

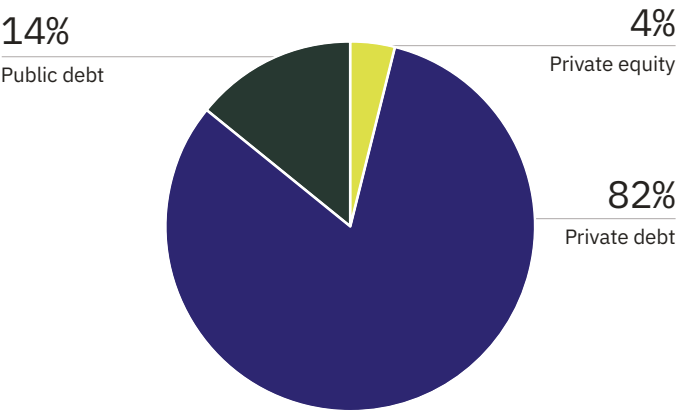
Outstanding investment portfolio

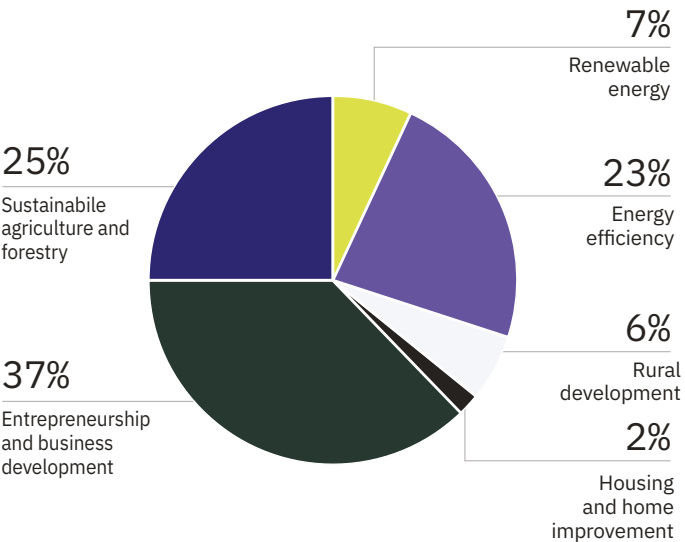
Outstanding investment portfolio

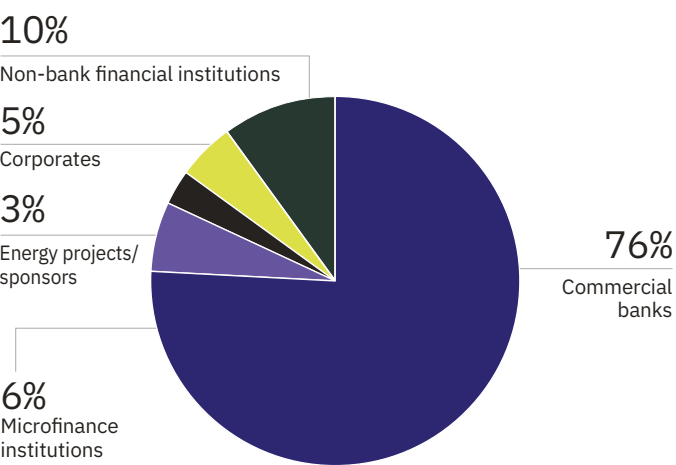
Outstanding investment portfolio

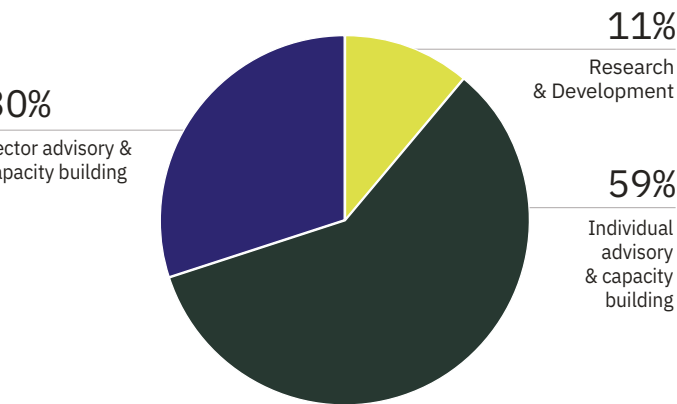
Outstanding investment portfolio
